- You must complete question 5 to apply for a place in **any** state school in **any** area. You should therefore include the schools you wish to apply for in Wandsworth **and** any schools outside Wandsworth.
- You can use this form to apply for up to **six** state schools. Don't include private schools. You may only complete one form.
- You should apply for **at least four** schools to increase your options. If you apply for one or two schools only, it **does not improve your chances** of being offered a place. If your application is unsuccessful, you will be offered a place at the nearest alternative school with an available place on 3 March. The alternative schools you could have applied for may already be full by this time, so you are advised to include them on your form now.
- If you are applying for schools some distance from your home, you are strongly advised to also apply for at least one school near to your home, because distance is used by many schools to decide which children are offered places.
- When you have decided which schools to apply for you must write them in the boxes at question 5 **in the order you prefer them**. Please only enter one school in each box.
- If your child can be allocated a place at **more than one** school, Wandsworth Council will offer you a place at **whichever of these** schools you put highest in your list in question 5. It is therefore very important that you list the schools in the right order as this cannot be changed later.
- If you have listed schools in other boroughs, we will pass the details of your application to the other borough councils.
- Your child will be considered **separately** for each school you apply for. The schools will not be told which other schools you have applied for, or the order in which you prefer the schools.
- Each school you apply for will decide whether it can allocate your child a place based on its published admissions criteria. Please read the criteria of the schools you are thinking of applying for before completing this form (see pages 18-39 of the *Choose a Wandsworth Secondary School* booklet or the booklets for schools in other areas).
- Before places are offered, Wandsworth Council will check whether your child can be allocated a place at more than one school. If you have applied for schools in other boroughs, we will also check with those councils whether your child can be allocated a place.

Wandsworth Year 6 Test

All children whose parents are applying to Ashcroft Technology Academy, Burntwood School, Chestnut Grove Academy or Graveney School must be registered by 4 September 2025 to be invited to the test. All registered children will take the test on 25, 26, 27 and 29 September 2025. Parents will be provided with the scores in mid October 2025.

Children In Public Care, children previously in state care (in England or another country) now adopted, or children previously in public care in England now subject to a residence order, a child arrangement order or special guardianship order.

The above children receive priority for admission to school. If the child for whom you are applying is in the care of a local authority or subject to the other situations described above, you must give details on the application form and provide documentary evidence to prove priority for admission.
