## 1. Statement of Representation

1.1. This statement has been prepared by the London Borough of Wandsworth (the Council) in relation to a consultation on the proposed Main Modifications to the Wandsworth Local Plan Partial Review (WLPPR).

# 2. Title of Document(s)

- Schedule of Proposed Main Modifications (November 2025)
- Addendum to the Sustainability Appraisal (November 2025)
- Addendum to the Habitat Regulations Assessment (November 2025)

### 3. Subject Matter

- 3.1. The Wandsworth Local Plan sets out the long-term strategic planning policy framework for the administrative area of the borough of Wandsworth. This consultation relates to an ongoing Partial Review of the Wandsworth Local Plan focussed on housing policies.
- 3.2. The documents (listed in section 2 above) are being made available for public inspection to provide any individual, organisation or business the opportunity to make representations for the consideration of an independent Planning Inspector. This Statement of Representations Procedure will also be available for inspection.
- 3.3. Once adopted, the Wandsworth Local Plan Partial Review is expected to update six policies in the current Local Plan. These policies apply to the whole of Wandsworth Borough and are:
  - Policy LP23: Affordable Housing
  - Policy LP24: Housing Mix
  - Policy LP28: Purpose-Built Student Accommodation
  - Policy LP29: Housing with Shared Facilities
  - Policy LP30: Build to Rent
  - Policy LP31: Specialist Housing for Vulnerable People and for Older People
  - 3.4. The Wandsworth Local Plan Partial Review was submitted to the Secretary of State for the purposes of independent examination in April 2025. The Secretary of State has appointed a Planning Inspector, Graham Wyatt BA (Hons) MRTPI, to undertake the examination of the plan. The Inspector held examination hearings between 4 and 6 November 2025.

- 3.5. The Inspector has subsequently asked the Council to consult on a schedule of proposed Main Modifications to the publication version of the Wandsworth Local Plan Partial Review. It is these Main Modifications that form the basis of the consultation to which this Statement relates.
- 3.6. Main Modifications are proposed changes to the version of the Local Plan Partial Review that the Council submitted to the Secretary of State in April 2025. These changes will affect the 'soundness' and/or 'legal compliance' of the plan. The changes being consulted on have been proposed by the Planning Inspector as part of the examination process. The changes proposed may be necessary to enable the Local Plan Partial Review to be formally adopted. The proposed Main Modifications consist of a schedule of the changes proposed in the order of the policies as they appear in the submitted version of the Local Plan Partial Review.

# 6. What to consider when making a representation

- 6.1. This consultation is **only** on the Inspector's proposed Main Modifications, and the published addendums, and not on matters relating to other aspects of the Local Plan Partial Review which have already been considered by the Inspector during the examination process and hearing sessions. Any representations received that do not relate to the Main Modifications may not be forwarded to the Inspector.
- 6.2. The Inspector wishes to consult on the Main Modifications to help him determine whether the Local Plan Partial Review, with the modifications proposed, is sound and meets legal requirements. There are four 'tests' of soundness which those looking to respond to the consultation should have regard to.
- 6.3. A Local Plan is considered 'sound' if it is:
  - Positively prepared, meaning that the plan is prepared based on a strategy which seeks
    to meet objectively assessed needs; and is informed by agreement with other
    authorities, so that unmet need from neighbouring areas is accommodated where it is
    practical to do so and is consistent with achieving sustainable development
  - Justified, meaning that the plan is an appropriate strategy, taking into account the reasonable alternatives, and is based on proportionate evidence
  - Effective, meaning that the plan is deliverable over its period (in this case 15 years), and is based on effective joint working on cross-boundary strategic matters
  - Consistent with national policy, meaning that the plan should enable the delivery of sustainable development in accordance with the polices in the NPPF and other statements of national planning policy

#### 7. How to make a representation

- 7.1. Representations are required to be made to the Council within the consultation period, between 26 November 2025 and 14 January 2026. Your comments must be received by 11:59pm on 14<sup>th</sup> January 2026.
- 7.2. Please note that you must include your full name and contact details. The Council cannot legally accept anonymous submissions during this representation period as these cannot be considered by the Planning Inspector. Please also note that your name and response will be made public as part of the examination process and that this is required by legislation and therefore complies with GDPR legislation. Representations should be made in writing via the following methods.

#### 8. Notification of Subsequent Changes

- 8.1. When making your representation you can request to be notified of the following stages of the Local Plan process:
  - the publication of the Inspector's recommendations following independent Examination of the Local Plan, and
  - the adoption of the Local Plan.
- 8.2. Once the representation period has closed, further updates regarding the status of the Local Plan Partial Review will be published on the Council's Planning Policy webpages. Any person who makes a submission during the representation period will automatically be added to the Council's Local Plan database and will be provided with updates on the progress of the Local Plan including when we submit our Local Plan for independent Examination, when the Planning Inspector's recommendations are published and when the Local Plan is adopted.
